#### SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. SBC provides regular and frequent communication to families through periodic letters from school leadership, a monthly newsletter for families and frequent communication between advisors and the parents of their advisees. With all the uncertainty surrounding COVID's spread and its impact on our community, we have significantly increased communication and family engagement.

## Stakeholder Engagement

Over the last several months, SBC leaders have collected data and engaged school stakeholders and community members in developing our plans.

- Parent/Family Engagement SBC has distributed a parent survey and newsletter to collect input and share information about critical needs in our community. In addition, the SBC Parent Committee has met to review elements of the plan while in development. SBC has also held virtual meetings with parents each month from June through October to provide information about health and safety protocols, remote learning, and academic and social and emotional learning needs and plans.
- Staff Engagement SBC has collected input from teachers about academic and social/emotional learning needs through meetings in July and August. SBC leaders conducted a Q&A/presentation with staff during staff orientation to discuss and receive input on the plans and to share input provided by families about the plans.

Community Engagement - SBC has also received guidance and support from its Board of Trustees, the community of school leaders across NYC affiliated with the NYC Charter Center and the NY State Charter Schools Association. In addition, SBC has collected student input through surveys and focus groups with student government and special education students.

SBC staff and students will be trained on recognizing potential symptoms and screening thresholds.

#### Cleaning and Disinfection

The CDC provides reopening guidance for cleaning and disinfection with specific guidance for schools along with the cleaning and disinfection decision tool to aid in determining what level of cleaning and/or disinfection is necessary. Funds will be used to enhance custodial plans. School wide cleaning must include classrooms, restrooms, cafeterias, libraries, playgrounds, and busses. The guidance provides a general framework for cleaning and disinfection practices. The framework is based on doing the following:

- Normal routine cleaning with soap and water will decrease how much of the virus is on surfaces and objects, which reduces the risk of exposure;
- Disinfection using US Environmental Protection Agency (EPA)-approved disinfectants against COVID-19. Where disinfectants are used, products should be registered with EPA and the NYS Department of Environmental Conservation (DEC). Frequent disinfection of surfaces and objects touched by multiple people is important;
- When EPA-approved disinfectants are not available, alternative disinfectants will be used (e.g., 1/3 cup of bleach added to 1 gallon of water or 70% alcohol solutions).
- Cleaning and disinfection will be performed daily
- · School custodians will maintain logs that include the date, time, and scope of cleaning and disinfection

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

Social, Emotional and Mental Health Data Collection: SBC uses periodic feedback surveys of all students to gauge key social, emotional and mental health indicators. The survey instrument aligns closely with the annual survey the NYC Department of Education uses as part of the School Quality Review Process. The categories include cultural awareness and inclusive classroom instruction. guidance, personal attention and support, bullying, safety and trust. SBC implements this survey 3 times a year and conducts data analysis through a rigorous Improvement Cycle process that identifies change ideas to improve school performance in these areas, wit ht eexplicit goal of improving positive responses on these surveys. In addition, staff have two advising touchpoints with students daily during remote learning - a morning check-in and afternoon check-out. This allows staff to get a sense of where their advisee's emotions are before entering virtual classrooms. It also helps students debrief their day and organize what they need to work on until classes resume. The data collected helps to identify students who may need additional support (counseling, technology, etc.).

Diagnostics and Interim Assessment: SBC uses computer based assessment systems that provide critical diagnostic and formative assessment data about student learning and growth. SBC students use their chromebooks to engage with these programs as a component of selective courses that provide differentiated guidance with essential literacy and numeracy skills. Computer-based programs are used that adhere to the following key criteria:

- Alignment to Common Core Standards and NYS assessments
- · Capacity to provide baseline diagnostic data about students reading comprehension and math skills
- Capacity to deliver interim assessments to students at least three times per year and provide staff with immediate access to student performance in an actionable format
- Quality of learning resources to engage and support students at a range of levels
- Ability to track and sort data relevant to student performance

SBC has used several technological platforms to meet students' needs and personalize learning. Programs that meet the stated criteria above include: Think Through Math (TTM), Achieve 3000, IXL, and Castle Learning. For example, Achieve 3000 provides *College/Career Readiness Reports* that forecast student ability to read and comprehend complex text, and thus their readiness for college and career, based on current Lexile and Common Core quantitative guidelines. Additionally, in alignment with our competency based system, IXL provides a diagnostic that informs teachers and students of their strengths and gaps by skill. IXL and Castle Learning are platforms that are consistently used to formatively assess student performance and growth.

The Academic Director and Lead Teachers facilitate improvement cycles with staff in which they analyze student performance data and develop goals, interventions, and benchmarks. All teachers are expected to assess baseline performance levels for the attainments in each course. This will be used to create Individualized Learning Plans, measure student growth, and evaluate curriculum and instruction. Team meetings are held weekly to engage in collaborative discussion of student learning and the development and implementation of our academic and socio-emotional curriculum. Staff has the flexibility to research, adapt, develop, and implement diagnostic and formative assessments to gain data to make informed decisions. Teachers formatively assess students through the use of projects, quizzes, essays, presentations and different uses of media. Formative assessments are often implemented with different pathways for students to demonstrate their understanding while using a predetermined rubric stating criteria for success. SBC engages in mock regents and practice exams for major summative assessments 3 times a year for students to prepare for the content and structure of the exam.

Summative Assessment: The SBC learning model has a robust emphasis on challenging, higher order thinking and complex problem solving, consistent with the Common Core Standards. SBC employs a strategy for summative assessments with multiple strands. SBC uses an external validation tool, the College and Work Readiness Assessment (CWRA+), which is administered twice, as a baseline at the beginning of 9th grade and then again at the end of 10th grade.

SBC continuously tunes teachers' assessments of competencies in relationship to the interim and summative data strategy described above. In addition to creating and norming attainment rubrics, teachers tune rubrics with the support of the leadership team of SBC. Lead Teachers curate exemplary student work as anchors associated with each attainment. These resources serve multiple purposes as:

- Guides to developing appropriate lessons, learning activities and assessment tasks that will produce appropriate levels of proficiency;
- Examples that students can use to grasp what is being asked of them and on which to model their own work; and
- · Measures against which student work and demonstrations can be measured.

In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

#### Targeted Support: Mid-Year Intensive and Mastery Intensive

While SBC employs real time data analysis to ensure that the learning program is attuned to meet the needs of students, SBC will also provide additional structures to ensure the students that are behind pace receive customized supports to accelerate their learning and acquisition of attainments.

Mid-Year Intensive is a week of differentiated supports for students. For accelerated students, SBC provides additional career and college exposure opportunities. For students behind pace, SBC provides small group instruction in the classes of need for each student.

Mastery Intensive is a three week program at the end of the school year, in July, for students behind pace. Students receive small group instruction customized to their learning deficits. Students in these programs are able to focus on attainments they were not able to acquire during the regular school year with more personalized attention to surface the skill gaps and other barriers to their success.

SBC's After School Program will provide academic enrichment for students. Advisors are in charge of monitoring the grades of their advisees. They are the first to refer students to after-school support, which is held on Tuesdays, Wednesdays, and Thursdays, with different subjects on certain days. After-school sessions allow students to receive direct support from their content teacher. Advisors document all meetings in a spreadsheet, noting progress or any issues. These are reviewed by team leads and brought to school leadership when needed. Because ALL academic and youth development staff are advisors, the school regularly covers professional development in a 4 week cycle on culturally relevant learning and relating to students. Depending on what the feedback is from the advising documents, the school will tailor the professional development to the student body's current needs.

6. In the space provided below, please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) - the allowable uses of funds - of the ARP Act.

SBC plans to spend the remaining funds on Learning Coaches, Social Workers and training in Healing Centered Engagement.

Throughout the school, SBC will bolster it's instructional program with two adults are in every classroom: an academic teacher and a learning coach. Learning coaches are tasked with supporting students toward social-emotional skill development, conducting one-on-one conferencing, and leading small group tutoring. They have expertise in youth development and work closely with teachers to provide support in academic classes as necessary. Learning coaches collaborate with teachers very closely on all aspects of their work since students bring similar strengths—and challenges—to all their classes, be it math, science, or CORE.

Healing Centered Engagement was coined by Dr. Shawn Ginwright in 2018 to advance a new and effective way to support young people of color and their adult allies with an asset based, and cultural rooted approach to healing and well-being. Healing Centered Practitioner Certification teaches school and youth development professionals how to address trauma by using healing centered practices and principles in afterschool settings, schools and classrooms.

7. Adding learning coaches will reduce the advising load for each staff member, meaning that each learning coach and each academic teacher is an advisor to 8-10 students from their advisory group. Advisors will meet with each of their students every two weeks to check in on goals, progress, and social and emotional competencies. The advisors will log their check-ins in a central advising tracker for all staff and school leaders to assess the emotional and mental state of the student body.

SBC will fortify it's personalized, competency-based model to provide all students with personalized learning plans. SBC uses a rigorous Response To Intervention (RTI) model and all students have access to differentiated supports including assistive technology, Learning Coaches, and tutoring. Support from Learning Coaches and a Lead Teacher certified in Special Education will ensure that students receive timely and thoughtfully developed personalized support, and necessary specialized services. Additionally, SBC will employ additional full-time mental health counselors to provide additional services for students in need of mental health support.

SBC has a Safety Team, which includes representation from the Board of Trustees, leadership team, staff, parents and students. The team meets quarterly to review policies and determine if any updates are needed based on new health information. The Safety Team convenes weekly when there are changes to the community conditions that may prompt an update to SBC's policies between quarterly meetings. The group provides input on key decisions and uses a consensus protocol when issues arise where there are strong opposing positions.

As we examine the current landscape around health and safety considerations, we recognize that there are no easy answers. The best way forward will be to work in partnership with our community to ensure we are considering all perspectives, and that we maintain, and continue to build, communal trust.

Plans are shared with the broader SBC community and all are invited to provide feedback directly to the members of the Safety Team, who are tasked with responding to feedback and updating the plan as needed.
